Regular Conformation: Altered & Intact: All classes divided by sex.

General Information:

- All entries must be submitted on the latest approved ASCA entry form, for the event in which your dog is entered. Entry forms are available on the ASCA website, at www.asca.org/home/busess-office/rules-forms. All non-ASCA dogs must have a QT Number in order to compete in obedience or rally trials. QT Number applications are available on the ASCA website or are available at the trial site.
- No entry shall be accepted from a dog or handler disqualified from the ASCA Conformation program; a dog or handler disqualified from all ASCA programs; or a person not in good standing with ASCA.
- Entry fees will not be returned if the show cannot be opened or be completed due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of CASA. Entry fees will not be refunded if the dog is absent, disqualified, excused or barred from competition, by the Show Committee, ASCA, show veterinarian or the judge
- **ENTRIES:** Payment in full must accompany entries and be made in US Funds. CASA will not run a tab for entries. Telephone, facsimile or incomplete entries will not be accepted. All entries **MUST** be on the enclosed entry form(s) with proper fees included. Exhibitors are responsible for the accuracy of the entry and the class entered. Withdrawals of entries will be accepted until the Pre-entry closing date listed; thereafter, no refunds will be made. Signature required for mailed entries WILL NOT BE ACCEPTED. No class changes will be allowed once entries have closed on the day of show or trial.
- Any check returned to CASA's bank will invalidate all entries associated with that check. Writer of the check will be required to pay a \$50 administrative fee, in addition to all bank charges associated with the returned check. Entry into future shows/trials and participation at this show/trial will not be allowed until all fees are paid in cash or money order. If the issue is not resolved within 10 days, the writer of said check will be reported to ASCA.
- Dogs over 6 months of age must have proof of ASCA registration available.

- CASA, the show/trial secretaries and club membership assume no responsibility for any loss, damage or injury sustained by any exhibitor, handler, dog, property, children or spectator.
- All dogs must be crated or leashed except while competing.
- Show building will be open and available to exhibitors at 7:30 am on show/trial dates. Building will be closed and locked each evening. No dogs may be let in the show building overnight.
- Shows/Trials will be held indoors on concrete floors covered with rubber matting. Crating space and grooming spaces are available in the building. Electricity is available; exhibitors may need an extension cord to reach an outlet near your setup.
- No food concessions on premises, but restaurants and convenience stores are nearby.

NEW: 2019 PARTICIPATION AWARD: CASA is offering an impact crate along with impact crate wheel cart, grooming arm/rail/pad. Entrants will be given one point for each CASA hosted show/trial entered in 2019, i.e., agility, conformation, obedience, rally and stock. Points are calculated per dog and entrants may not combine points for multiple dogs. Points are awarded based on entries alone, not qualifying scores...so the more events you enter, the more points, you receive. Points are awarded for the event entry only, so owners who have handlers will receive points for any discipline show/trial entered. The impact crate will be awarded to the entrant with the most points at the conclusion of the October 19, 2019, conformation show event.
